Forfeiture of Incentive Rights – Appendix 3B

At a Board meeting of WPG Resources Ltd (WPG or the Company) held today, the Directors resolved to reduce the number of incentive rights previously granted to employees who have left the Company. The Incentive Rights Plan sets out the treatment of unvested incentive rights for employees who leave the Company and under these rules 736,882 rights (vesting date 1 July 2015) are forfeited. The number of Incentive Rights with a vesting date of 1 July 2015 is therefore reduced by 736,882 rights.
