Grant of Incentive Rights – Appendix 3B and Appendix 3Y

Following approval at the 2013 Annual General Meeting of WPG Resources Ltd (WPG or the Company) held today, the Company has granted 527,922 Incentive Rights to one Executive Director. The proposed grant of these rights was first advised on 12 July 2013, when 5,338,751 Incentive Rights were granted to senior executives.

Attached are completed Appendix 3B and Appendix 3Y Notices with respect to this Incentive Rights issue.

Additional information is also included in the attached Appendix 3B pursuant to the approval of a resolution to issue equity securities equivalent to an additional 10% of the number of ordinary securities on issue by way of placements over a 12 month period under Listing Rule 7.1A passed by special resolution today. The Board has no current intention to undertake a placement of shares, rather, the approval of the resolution provides the Board with the maximum flexibility with regard to future capital raising or asset acquisitions.
